Sat/Sun October 18 & 19, 2025 RAIN OR SHINE 10 AM to 5 PM

Arts of Fluvanna County announces its 2025 JURIED Studio Tour which will feature artist/artisan studios across Fluvanna County, Virginia. The Studio Tour will take place on Oct 18 & 19, 2025 from 10 AM to 5 pm. All exhibitors must be juried through the jury application process. Every exhibiting artist/studio will be located in Fluvanna County.

DATES: March 1, 2025 - Jury application, images and \$30 Application Fee due

March 20, 2025 - Notification of jury results

May 1, 2025 - If accepted: Participation Form and \$150 Exhibit Fee due

Oct 18 & 19, 2025 - 10 AM - 5 pm - Rain or Shine - Arts of Fluvanna County STUDIO TOUR

CRITERIA FOR ARTISTS

- Artists <u>must live or exhibit in</u> Fluvanna County, VA. *Applications will be considered from artists in neighboring counties, located nearby.*
- Design and produce handmade artwork/craft, according to the criteria described below.
- Demonstrate consistent skill across work in the submitted media category.
- Be available by phone or email for questions that may arise during tour planning.
- Be present with displayed work for the entire event 10 a.m. 5 p.m., Sat & Sun Oct 18 & 19, 2025.
- All artists and assistants must abide by Tour guidelines for safety: following current health and safety
 October 2025 CDC recommendations. (Masks may be required of participants.)
- Have an accessible studio <u>OR</u> have tent/display equipment to show at a specified location. The Tour works to arrange shared spaces, and/or an interior location for artists without accessible studios.
- Provide Certificate of Liability Insurance.

<u>It is suggested</u> that artists provide some sort of visual illustration or explanation of the creative process during the tour: i.e. a demonstration, a slideshow, a video, a poster, or any other informative display.

CRITERIA FOR WORK

- Be original, designed and hand produced by the artist.
 - Cards/Reproductions of original work must be labeled as such. (less than 10% of display)
- Exhibit excellence of craftsmanship and technique appropriate for the medium and style, with works possessing durability and integrity appropriate to the medium and the intent of the artisan.
- Be professionally displayed and labeled as to content, care, and price.

NOTE: Work made from kits, commercial patterns or commercial molds will not be considered.
